vi) Any undeclared Dangerous Goods shipments will need to be removed and represented. Check fees and security charges will be charged twice.
vii) A surcharge applies to all payments made by Debit/Credit Card
viii) A late payment charge of 3% will apply if payment not made after 30 days from invoice date this will be on the full invoice not prorata.
ix) A surcharge of 5% on the amount paid applies to all cash payments and is payable immediately.
