Question	Answers
<b>How do I participate in the AGM?</b>	<p>To keep physical interactions and COVID-19 transmission risk to a minimum, SATS Ltd. (“<b>SATS</b>” or the “<b>Company</b>”) is not providing for physical attendance by shareholders at the AGM. Instead, the AGM will be conducted virtually. To facilitate shareholder engagement, the Company will implement real-time remote electronic voting (“live” voting) and real-time electronic communications (“live” Q&amp;A) at the AGM.</p> <p>To attend the AGM, you (including, where applicable, your appointed proxy(ies)) must pre-register at the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a> <b>from 10.00 a.m. on 23 June 2022 up to 10.00 a.m. on 19 July 2022.</b></p> <p>Following verification, authenticated shareholders (including CPF and SRS investors) and, where applicable, their appointed proxy(ies), who have pre-registered via the pre-registration website will receive a confirmation email by <b>10.00 a.m. on 21 July 2022</b>. The confirmation email will set out instructions on how to access the live audio-visual webcast and live audio-only stream of the AGM proceedings, how to submit relevant text-based questions “live”, and how to vote “live” at the AGM via the audio-visual webcast platform.</p> <div style="border: 1px solid black; padding: 5px;"><p><b>Please note that the pre-registration website and live audio-visual webcasts are not supported by Internet Explorer. <b>Why do I need to provide my or my proxy(ies)' full NRIC or passport number?</b>	<p>This enables SATS to verify your identity and status as a shareholder or, where applicable, the identity and status of your appointed proxy(ies) in order to ensure that only authenticated shareholders (including CPF and SRS investors) and, where applicable, their appointed proxy(ies) will receive the confirmation email to access the live audio-visual webcast and live audio-only stream of the AGM proceedings.</p>

Who can pre-register for the live AGM proceedings?	<p>Shareholders of SATS (including CPF and SRS investors) and, where applicable, their appointed proxy(ies) will be able to pre-register <b><u>from 10.00 a.m. on 23 June 2022 up to 10.00 a.m. on 19 July 2022</u></b> to observe and/or listen to the live audio-visual webcast or live audio-only stream of the AGM proceedings.</p> <p>The appointed third party proxy(ies), other than the Chairman of the Meeting (“<b>Third Party Proxy(ies)</b>”) will be prompted via email (within 2 business days after the Company’s receipt of a validly completed and submitted instrument appointing a proxy(ies)) to pre-register. The email will contain a proxy code for use in the pre-registration.</p> <p><b>Shareholders who wish to appoint Third Party Proxy(ies) are encouraged to submit their instruments appointing a proxy(ies) early, and should request their proxy(ies) to pre-register by 10.00 a.m. on 19 July 2022.</b></p>
Do Third Party Proxy(ies) have to pre-register via the pre-registration website in order to attend the AGM?	Yes, Third Party Proxy(ies) must pre-register in order to attend the AGM.
If I am a CPF or SRS investor, can I pre-register for the live AGM proceedings?	Yes, you may pre-register at the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a> <b><u>from 10.00 a.m. on 23 June 2022 up to 10.00 a.m. on 19 July 2022</u></b> to observe and/or listen to the live audio-visual webcast or live audio-only stream of the AGM proceedings.
If I hold the Company’s shares via a securities sub-account maintained with a depository agent, can I pre-register for the live AGM proceedings?	<p>We regret to inform you that you will not be able to pre-register via our pre-registration website.</p> <p>You may contact the relevant intermediary through which you hold your shares in the Company <b><u>as soon as possible</u></b>, in order for the necessary arrangements to be made for you to participate in the AGM.</p>
Is there a deadline to pre-register on the pre-registration website?	Yes, please complete the pre-registration <b><u>before 10.00 a.m. on 19 July 2022</u></b> . Only authenticated shareholders (including CPF and SRS investors) and, where applicable, their appointed proxy(ies) who have pre-registered before the deadline will be allowed access to the live AGM proceedings.

<p><b>When would I receive the confirmation email for the live AGM proceedings?</b></p>	<p>Authenticated shareholders (including CPF and SRS investors) and, where applicable, their appointed proxy(ies) who have pre-registered via the pre-registration website will receive a confirmation email via the email address provided on pre-registration by <b><u>10.00 a.m. on 21 July 2022</u></b>.</p> <p>Shareholders (including CPF and SRS investors) and, where applicable, their appointed proxy(ies), who do not receive the confirmation email by <b><u>10.00 a.m. on 21 July 2022</u></b>, but have registered by the 19 July 2022 deadline, should contact our Share Registrar, M &amp; C Services Private Limited, at +65 6228 0506 or via email at <a href="mailto:gpe@mncsingapore.com">gpe@mncsingapore.com</a> before 7.00 p.m. on 21 July 2022 or between 8.00 a.m. and 9.00 a.m. on 22 July 2022.</p>

<p><b>How do I vote “live” for the resolutions which are being tabled at the AGM?</b></p>	<p>Shareholders and, where applicable, their appointed proxy(ies) who wish to vote “live” via electronic means at the AGM must first pre-register at the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a> by <b><u>10.00 a.m. on 19 July 2022</u></b>.</p> <p>Authenticated shareholders and, where applicable, their appointed proxy(ies) will receive a confirmation email by <b><u>10.00 a.m. on 21 July 2022</u></b>. The confirmation email will set out instructions on how to access the live audio-visual webcast and live audio-only stream of the AGM proceedings, how to submit relevant text-based questions “live”, and how to vote “live” at the AGM via the audio-visual webcast platform.</p>

<b>If I am a CPF or SRS investor, how can I vote “live” at the AGM?</b>	<p>If you are a CPF or SRS investor, you may vote “live” at the AGM if you are appointed as a proxy by your CPF Agent Bank or SRS Operator through which you hold your shares in the Company. Please approach your CPF Agent Bank or SRS Operator if you have any queries regarding your appointment as a proxy.</p> <p>Alternatively, you may appoint the Chairman of the Meeting as your proxy to vote on your behalf at the AGM, in which case, you should approach your CPF Agent Bank or SRS Operator to submit your votes by <b><u>5.00 p.m. on 12 July 2022.</u></b></p>
<b>If I am a CPF or SRS investor, can I appoint a Third Party Proxy(ies) to vote “live” at the AGM?</b>	<p>No, you will not be able to appoint Third Party Proxy(ies) (i.e., persons other than the Chairman of the Meeting) to vote “live” at the AGM on your behalf.</p> <p>If you wish to appoint the Chairman of the Meeting as your proxy to vote on your behalf at the AGM, you should approach your CPF Agent Bank or SRS Operator to submit your votes by <b><u>5.00 p.m. on 12 July 2022.</u></b></p>
<b>How can I vote “live” if I hold the Company’s shares via a securities sub-account in a depository agent?</b>	<p>If you hold the Company’s shares via a securities sub-account in a depository agent and wish to vote “live” on the resolutions to be tabled for approval at the AGM, please contact the relevant intermediary through which you hold your shares in the Company <b><u>as soon as possible</u></b>, in order for the necessary arrangements to be made for your participation in the AGM.</p>

<p><b>How can I submit the instrument appointing a Third Party Proxy(ies) or Chairman of the Meeting as proxy to vote “live” on my behalf?</b></p>	<p>Instruments appointing a proxy(ies) must be submitted in the following manner:</p> <p>a. <b>if by post</b>, to be lodged with the Company’s Share Registrar, M &amp; C Services Private Limited, at 112 Robinson Road #05-01, Singapore 068902;</p> <p>b. <b>if electronically, be submitted</b></p> <p>(i) via email to the Company’s Share Registrar at <a href="mailto:gpe@mncsingapore.com">gpe@mncsingapore.com</a>; or</p> <p>(ii) via the online process through the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>,</p> <p>in each case, by <b>10.00 a.m. on 19 July 2022</b>.</p> <p>Shareholders who wish to submit an instrument appointing a proxy(ies) by post or via email must first download, complete and sign the proxy form before submitting it by post to the address provided above, or before submitting it via email (e.g., by enclosing a completed and signed PDF copy of the proxy form) to the email address provided above. Shareholders may also appoint a proxy(ies) via the online process through the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>.</p> <p><b>Shareholders are strongly encouraged to submit completed instruments appointing a proxy(ies) electronically via email or via the online process through the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>.</b></p> <p>CPF and SRS investors should <u>not</u> submit instruments appointing a proxy(ies). CPF and SRS investors who wish to appoint themselves as a proxy to vote “live”, or the Chairman of the Meeting as their proxy to vote on their behalf, at the AGM should approach their respective CPF Agent Banks or SRS Operators to submit their votes by <b>5.00 p.m. on 12 July 2022</b>. CPF and SRS investors will not be able to appoint Third Party Proxy(ies) (i.e., persons other than the Chairman of the Meeting) to vote at the AGM on their behalf.</p> <p>Persons who hold shares through relevant intermediaries (other than CPF and SRS investors) should not submit instruments appointing a proxy(ies). Instead, they should contact the relevant intermediary through which they hold such shares <b>as soon as possible</b> in order for the necessary arrangements to be made for their participation in the AGM.</p>

<b>Where can I find the proxy form?</b>	<p>The proxy form can be found on the:</p> <p>a. pre-registration website of the Company at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>; and</p> <p>b. SGX website at the URL <a href="https://www.sgx.com/securities/company-announcements">https://www.sgx.com/securities/company-announcements</a>.</p>
<b>Can I appoint two proxies to attend the AGM on my behalf?</b>	<p><b>A shareholder (who is not a relevant intermediary)</b> is entitled to appoint not more than two proxies to attend, speak and vote at the AGM. Where a shareholder’s instrument appointing a proxy(ies) appoints more than one proxy, the proportion of the shareholding concerned to be presented by each proxy shall be specified in the instrument.</p> <p><b>A shareholder who is a relevant intermediary</b> is entitled to appoint more than two proxies to attend, speak and vote at the AGM, but each proxy must be appointed to exercise the rights attached to a different share or shares held by such shareholder. Where such shareholder’s instrument appointing a proxy(ies) appoints more than two proxies, the number and class of shares in relation to which each proxy has been appointed shall be specified in the instrument.</p>
<b>Can I appoint two proxies in the alternative to attend the AGM on my behalf?</b>	<p>Yes. Where a shareholder (not being a relevant intermediary) appoints two proxies in the alternative, the two proxies will each receive a different proxy code to access the AGM portal on the AGM day to attend and participate “live” during the proceedings through electronic means.</p> <p><b>In the event that the proportion of the shareholding concerned to be presented by each proxy is not specified in the instrument and both proxies access the live audio-visual webcast of the AGM proceedings, only the votes cast during the “live” voting by the proxy who first accessed the live audio-visual webcast will be counted.</b></p>
<b>Can I appoint two proxies jointly to attend the AGM on my behalf?</b>	<p>Yes. Where a shareholder (not being a relevant intermediary) appoints two proxies jointly, each in respect of a specified proportion of his/her/its shareholding, different proxy codes will be assigned to both proxies.</p> <p>Both proxies will be able to access the live audio-visual webcast and live audio-only stream of the AGM proceedings, but will only be able to vote via the live audio-visual webcast of the AGM proceedings in respect of the specified proportion of shareholding in respect of which that proxy has been appointed.</p>

<b>Question</b>	<b>Answers</b>
<b>Is there a deadline to submit instruments appointing a proxy(ies)?</b>	Yes, all instruments appointing a proxy(ies) must be submitted by <b><u>10.00 a.m. on 19 July 2022.</u></b>
<b>If I have submitted a proxy form but subsequently decide to attend the AGM personally, can I withdraw my proxy form?</b>	<p>Yes. Completion and return of the instrument appointing a proxy(ies) does not preclude a shareholder from attending, speaking and voting at the AGM.</p> <p>You may view, resubmit or withdraw your proxy appointments <b><u>before 10.00 a.m. on 19 July 2022</u></b> via the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>.</p> <p>After you have appointed a proxy(ies) to attend, speak and vote at the AGM on your behalf, you will be given observer rights where you can observe and listen to the AGM proceedings via the live audio-visual webcast platform. As an observer, you will be able to submit text-based questions “live” but cannot vote “live” at the AGM.</p> <p>Should you decide to attend the AGM and log in on the actual day of the AGM, i.e., on 22 July 2022 at 10.00 a.m., a prompt window asking if you would like to revoke your proxy appointment(s) will appear. If you select “Yes”, you will be automatically given the full rights to participate in the AGM, including the ability to submit text-based questions “live” and vote “live” at the AGM. Your proxy(ies)’ rights to participate at the AGM will then be revoked and the instrument appointing a proxy(ies) will be treated as null and void. This means that your appointed proxy(ies) will no longer be allowed to access, observe or listen to the AGM proceedings and will not be able to submit text-based questions “live” or vote “live” on your behalf.</p>

<b>How would I be able to submit questions in advance of the AGM?</b>	<p>Shareholders (including CPF and SRS investors) can submit substantial and relevant questions related to the resolutions to be tabled for approval at the AGM to the Chairman of the Meeting, in advance of the AGM, in the following manner:</p> <p>a. <b>Via pre-registration website.</b> Shareholders (including CPF and SRS investors) who pre-register to observe and/or listen to the AGM proceedings may submit your questions via the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>.</p> <p>b. <b>Via email.</b> Shareholders (including CPF and SRS investors) may submit your questions via email at <a href="mailto:sats_ir@sats.com.sg">sats_ir@sats.com.sg</a>.</p> <p>c. <b>By post.</b> Shareholders (including CPF and SRS investors) may submit your questions by post to the Company's Share Registrar, M &amp; C Services Private Limited, at 112 Robinson Road #05-01, Singapore 068902.</p> <p>When submitting your questions via email or by post, please also provide us with the following details:</p> <ul style="list-style-type: none"><li>• your full name;</li><li>• your address; and</li><li>• the manner in which you hold shares in SATS (e.g., via CDP, CPF, SRS and/or scrip).</li></ul> <p>All questions submitted in advance of the AGM via any of the above channels must be submitted by <b>5.00 p.m. on 12 July 2022</b>.</p>

<p><b>Would all the questions submitted in advance of the AGM be addressed?</b></p>	<p>The Company will address substantial and relevant questions received by the 12 July 2022 deadline from shareholders by publishing our responses to such questions on the Company's website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a> and on the SGX website at the URL <a href="https://www.sgx.com/securities/company-announcements">https://www.sgx.com/securities/company-announcements</a> by 16 July 2022.</p> <p>We will address any subsequent clarifications sought, or substantial and relevant follow-up questions (which are related to the resolutions to be tabled for approval at the AGM) received after the 12 July 2022 deadline which have not already been addressed prior to the AGM, as well as those substantial and relevant text-based questions received "live" at the AGM itself, during the AGM through the live audio-visual webcast and live audio-only stream of the AGM proceedings.</p> <p><b>Where substantially similar questions are received, we will consolidate such questions, and consequently, not all questions may be individually addressed.</b></p>

<p><b>How would I be able to ask questions "live" at the AGM?</b></p>	<p>Shareholders and, where applicable, their appointed proxy(ies) (including CPF and SRS investors) can ask substantial and relevant questions related to the resolutions to be tabled for approval at the AGM, "live" at the AGM, by submitting text-based questions via the online platform hosting the audio-visual webcast. Using your computer, tablet, or mobile phone, you can type in and submit your questions through the "live" chat function via the audio-visual webcast platform.</p> <p>Shareholders and, where applicable, their appointed proxy(ies) (including CPF and SRS investors) will <u>not</u> be able to submit text-based questions "live" at the AGM <u>via the audio-only stream</u> of the AGM proceedings.</p> <p>Please note that shareholders and, where applicable, their appointed proxy(ies) (including CPF and SRS investors) who wish to submit text-based questions "live" via the audio-visual webcast platform during the AGM must pre-register by <b><u>10.00 a.m. on 19 July 2022</u></b> at the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2022">https://www.sats.com.sg/AGM2022</a>.</p>

<b>Question</b>	<b>Answers</b>
<b>Would all the questions asked “live” at the AGM be addressed?</b>	<p>During the AGM, we will endeavour to address as many substantial and relevant questions (which are related to the resolutions to be tabled for approval at the AGM) which have not already been addressed prior to the AGM, as well as those text-based questions, received “live” via the audio-visual webcast platform at the AGM, as we can.</p> <p><b>Where substantially similar questions are received, we will consolidate such questions, and consequently, not all questions may be individually addressed.</b></p>
<b>Would the attendees at the AGM be able to see the “live” questions raised by all the shareholders and proxies during the webcast?</b>	<p>No, shareholders and, where applicable, their appointed proxy(ies) will not be able to see the questions raised by other shareholders and appointed proxies.</p>
<b>Would I and my proxy(ies) be able to ask questions “live” simultaneously at the AGM?</b>	<p>Yes, you and your appointed proxy(ies) will be able to ask questions “live” at the AGM simultaneously via the live audio-visual webcast platform.</p>
<b>Would I or my proxy(ies) be able to ask questions “live” at the AGM if I am or my proxy(ies) is/are listening to the audio-only stream of the AGM proceedings?</b>	<p>No, you and, where applicable, your appointed proxy(ies) will <u>not</u> be able to submit text-based questions “live” at the AGM via the audio-only stream of the AGM proceedings. The “live” Q&amp;A function is only available on the audio-visual webcast of the AGM proceedings.</p>

<b>How do I or my proxy(ies) submit my votes “live” at the AGM?</b>	<p>The intention is that all the 14 resolutions to be tabled for approval at the AGM will be proposed and thereafter put to the vote concurrently by poll at the AGM.</p> <p><b><u>Voting instructions for shareholders:</u></b></p> <p>Once voting commences, all the 14 resolutions and the voting options will appear automatically on the screen. You can proceed to cast your votes for the resolutions. You should click “For” if you wish to vote for the relevant resolution, click “Against” if you want to vote against the relevant resolution, or click “Abstain” if you wish to abstain from voting on the relevant resolution. Click on the “Submit All Votes” button after you have selected the relevant options for all the resolutions.</p> <p>If you wish to change your vote, you can select a new choice for the relevant resolution. If you wish to withdraw your vote, you should click “Cancel” for the relevant resolution.</p> <p>If you do not select “For”, “Against”, or “Abstain” in relation to any resolution before voting closes, your vote will <u>not</u> be recorded and you will be regarded as having abstained from voting in respect of the relevant resolution.</p> <p><b><u>Voting instructions for proxy(ies):</u></b></p> <p>Where the shareholder has already indicated his/her/its specific voting instructions on the instrument appointing a proxy(ies), the voting option for the proxy(ies) to vote on the resolutions tabled at the AGM cannot be edited. The voting will be based on the specified voting instructions. Appointed proxy(ies) should click on the “Submit All Votes” button. If the proxy(ies) does not submit the votes, the votes will not be recorded.</p> <p>Where the shareholder has not provided specific voting instructions on the instrument appointing a proxy(ies), the appointed proxy(ies) can vote “live” at the AGM according to his/her/their discretion. Appointed proxy(ies) can refer to the section above on “Voting instructions for shareholders” for their voting procedures.</p> <p>You and, where applicable, your appointed proxy(ies) must access the AGM proceedings via the “live” audio-visual webcast to vote “live” at the AGM. You will <u>not</u> be able to do so via the audio-only stream of the AGM proceedings.</p>
