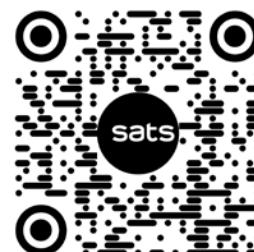
The SGXNet Announcement sets out detailed instructions on how shareholders may participate in the AGM by observing and/or listening to the AGM proceedings via “live” audio-visual webcast or “live” audio-only stream, submitting questions to the Chairman of the Meeting in advance of, or “live” via text-based questions through the audio-visual webcast platform at the AGM and/or voting at the AGM (i) “live” by the shareholders themselves or their duly appointed proxy(ies) (other than the Chairman of the Meeting) via electronic means; or (ii) by appointing the Chairman of the Meeting as proxy to vote on their behalf at the AGM.
