Dear Shareholder,

SATS Ltd. (“**SATS**”) will be convening and holding an Extraordinary General Meeting (“**EGM**”) at Singapore EXPO, Hall 1 (APEX), 1 Expo Drive, Singapore 486150 (“**Physical Meeting**”) and by way of electronic means (“**Virtual Meeting**”) on Wednesday, 18 January 2023 at 2.30 p.m. (Singapore time) to seek shareholders’ approval for the proposed acquisition of Worldwide Flight Services (“**Proposed Acquisition**”).

A circular in relation to the Proposed Acquisition (“**Circular**”), together with the Notice of EGM, Proxy Form, Gatefold and Frequently Asked Questions in relation to the Proposed Acquisition, will be published on the SATS website at the URL <https://www.sats.com.sg/egm> and on the SGX website at the URL <https://www.sgx.com/securities/company-announcements> from 3 January 2023. Hard copies of the Notice of EGM, Proxy Form, Gatefold and Frequently Asked Questions are enclosed. However, **hard copies of the Circular will not be sent to shareholders.**

Arrangements relating to:

- (a) in-person attendance at the EGM (including arrangements by which shareholders or their appointed proxy(ies) can pre-register for the Physical Meeting);
- (b) attendance at the EGM via electronic means (including arrangements by which the Virtual Meeting can be electronically accessed via live audio-visual webcast or live audio-only stream);
- (c) submission of questions to the Chairman of the Meeting in advance of, or live at, the EGM, and addressing of substantial and relevant questions in advance of, or live at, the EGM; and
- (d) voting at the EGM: (i) live by the shareholder or his/her/its duly appointed proxy(ies) (other than the Chairman of the Meeting) via electronic means; or (ii) by appointing the Chairman of the Meeting as proxy to vote on the shareholder’s behalf at the EGM,

are set out in Appendix C to the Circular.

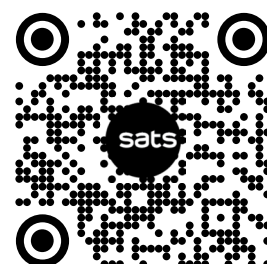
