How do I participate in the EGM?	<p>SATS Ltd. (“SATS” or the “Company”) will be convening and holding an Extraordinary General Meeting (“EGM”) at Singapore EXPO, Hall 1 (APEX), 1 Expo Drive, Singapore 486150 (“Physical Meeting”) and by way of electronic means (“Virtual Meeting”) on Wednesday, 18 January 2023 at 2.30 p.m. (Singapore time).</p> <p>Shareholders (including, where applicable, their appointed proxy(ies)) and CPF and SRS investors who wish to attend the Physical Meeting or the Virtual Meeting can pre-register for the EGM at the pre-registration website at the URL https://www.sats.com.sg/egm from 2.30 p.m. on 3 January 2023 up to 2.30 p.m. on 15 January 2023 to enable the Company to verify their status.</p> <p>Shareholders (including, where applicable, their appointed proxy(ies)) and CPF and SRS investors who wish to attend the Physical Meeting should indicate their intention to do so at the pre-registration website.</p> <p>Following verification, authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have pre-registered via the pre-registration website will receive either an email confirming physical attendance for the Physical Meeting or an email confirming virtual attendance for the Virtual Meeting, by 2.30 p.m. on 17 January 2023. The confirmation email for both the Physical Meeting and the Virtual Meeting will set out instructions on how to access the Virtual Meeting.</p> <p>Authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who are successful in the pre-registration for the Physical Meeting but are subsequently unable to attend the Physical Meeting for any reason, may nevertheless participate in the EGM via electronic means at the Virtual Meeting instead.</p> <div style="border: 1px solid black; padding: 5px;"><p>Please note that the pre-registration website and live audio-visual webcast are not supported by Internet Explorer. <p>Why do I need to provide my or my proxy(ies)' full NRIC(s) or passport number(s)?</p>	<p>This enables SATS to verify your identity and status as a shareholder or, where applicable, the identity and status of your appointed proxy(ies) in order to ensure that only authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies) will receive the confirmation email confirming physical attendance for the Physical Meeting or virtual attendance for the Virtual Meeting.</p>
<p>Who can pre-register for the live EGM proceedings?</p>	<p>Shareholders of SATS (including, where applicable, their appointed proxy(ies)) and CPF and SRS investors will be able to pre-register <u>from 2.30 p.m. on 3 January 2023 up to 2.30 p.m. on 15 January 2023</u> to attend the Physical Meeting or the Virtual Meeting.</p> <p>Appointed proxy(ies) other than the Chairman of the Meeting ("Third Party Proxy(ies)") will be prompted via email (within 2 business days after the Company's receipt of a validly completed and submitted instrument appointing a proxy(ies)) to pre-register for the EGM. The email will contain a proxy code for use in the pre-registration.</p> <p>Shareholders who wish to appoint Third Party Proxy(ies) are encouraged to submit their instruments appointing a proxy(ies) early, and should request their proxy(ies) to pre-register by 2.30 p.m. on 15 January 2023.</p>
<p>If I am a CPF or SRS investor, can I pre-register for the live EGM proceedings?</p>	<p>Yes, you may pre-register at the pre-registration website at the URL https://www.sats.com.sg/egm <u>from 2.30 p.m. on 3 January 2023 up to 2.30 p.m. on 15 January 2023</u> to attend the Physical Meeting or the Virtual Meeting.</p>

If I hold the Company's shares via a securities sub-account maintained with a depository agent, can I pre-register for the live EGM proceedings?	<p>We regret to inform you that you will not be able to pre-register via our pre-registration website.</p> <p>You should contact the relevant intermediary through which you hold your shares in the Company as soon as possible, in order for the necessary arrangements to be made for you to participate in the EGM.</p>
Is there a deadline to pre-register on the pre-registration website?	<p>Yes, please complete the pre-registration before 2.30 p.m. on 15 January 2023. Authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have pre-registered before the deadline will be allowed to attend the Physical Meeting or the Virtual Meeting.</p>
When would I receive the confirmation email for the live EGM proceedings?	<p>Authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have pre-registered via the pre-registration website will receive a confirmation email via the email address provided on pre-registration by 2.30 p.m. on 17 January 2023.</p> <p>Shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who do not receive any confirmation email by 2.30 p.m. on 17 January 2023, but have registered by 2.30 p.m. on 15 January 2023, should contact the Company's Share Registrar, M & C Services Private Limited, at +65 6228 0506 or via email at gpe@mncsingapore.com between 2.30 p.m. and 6.00 p.m. on 17 January 2023 or between 9.00 a.m. and 1.00 p.m. on 18 January 2023 for assistance.</p>
What happens if the Company is unable to verify my status as a shareholder?	<p>You will receive an email by 2.30 p.m. on 17 January 2023 notifying you that we could not verify your shareholder status and, therefore, you and, where applicable, your appointed proxy(ies) will not be given access to the EGM proceedings.</p> <p>If you have any questions on the verification status, please contact our Share Registrar, M & C Services Private Limited, at +65 6228 0506 or via email at gpe@mncsingapore.com between 2.30 p.m. and 6.00 p.m. on 17 January 2023 or between 9.00 a.m. and 1.00 p.m. on 18 January 2023.</p>
If I am feeling unwell or decide not to attend the Physical Meeting, can I still attend the Virtual Meeting?	<p>Yes, authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have pre-registered and indicated their intention to attend the Physical Meeting via the pre-registration website, can attend the Virtual Meeting.</p> <p>You may refer to the confirmation email which sets out instructions on how to access the Virtual Meeting (i.e., via the live audio-visual webcast and live audio-only stream of the EGM proceedings), how to submit relevant text-based questions live, and how to vote live at the EGM via the audio-visual webcast platform.</p>

If I have pre-registered to attend the Virtual Meeting, can I still attend the Physical Meeting?	<p>Yes, authenticated shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have pre-registered and indicated their intention to attend the Virtual Meeting via the pre-registration website, can attend the Physical Meeting.</p> <p>Please note that you will need to register in person at the registration counter(s) outside the EGM venue on the day of the EGM. Registration will commence at 1.00 p.m. on that day. Please bring along your NRIC/passport to enable SATS to verify your identity. As voting at the Physical Meeting will be conducted via an online platform, please also bring along a web-browser enabled device in order to access the voting function at the EGM.</p>

Question	Answers
How do I vote live for the resolution which is being tabled at the EGM?	<p>Shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who wish to vote live at the EGM should first pre-register at the pre-registration website at the URL https://www.sats.com.sg/egm by <u>2.30 p.m. on 15 January 2023</u>.</p> <p>Shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who have not pre-registered at the pre-registration website but register in person at the registration counter(s) outside the EGM venue on the day of the EGM can, subject to verification, also vote live at the EGM as long as they have shares entered against their names in the Depository Register 72 hours before the time appointed for holding the EGM, as certified by The Central Depository (Pte) Limited to the Company, or are appointed proxy(ies) of such persons.</p>
If I am a CPF or SRS investor, how can I vote live at the EGM?	<p>If you are a CPF or SRS investor, you may vote live at the EGM if you are appointed as a proxy by your CPF Agent Bank or SRS Operator through which you hold your shares in the Company. Please approach your CPF Agent Bank or SRS Operator if you have any queries regarding your appointment as a proxy.</p> <p>Alternatively, you may appoint the Chairman of the Meeting as your proxy to vote on your behalf at the EGM, in which case, you should approach your CPF Agent Bank or SRS Operator to submit your votes by <u>5.00 p.m. on 6 January 2023</u>.</p>
If I am a CPF or SRS investor, can I appoint a Third Party Proxy(ies) to vote live at the EGM?	<p>No, you will not be able to appoint Third Party Proxy(ies) (i.e., persons other than the Chairman of the Meeting) to vote live at the EGM on your behalf.</p>
How can I vote live if I hold the Company's shares via a securities sub-account maintained with a depository agent?	<p>If you hold the Company's shares via a securities sub-account maintained with a depository agent and wish to vote live on the resolution to be tabled for approval at the EGM, please contact the relevant intermediary through which you hold your shares in the Company <u>as soon as possible</u>, in order for the necessary arrangements to be made for your participation in the EGM.</p>

<p>How can I submit the instrument appointing a Third Party Proxy(ies) or Chairman of the Meeting as proxy to vote live on my behalf?</p>	<p>Instruments appointing a proxy(ies) must be submitted in the following manner:</p> <p>a. if submitted by post, be lodged with the Company's Share Registrar, M & C Services Private Limited, at 112 Robinson Road #05-01, Singapore 068902; or</p> <p>b. if submitted electronically, be submitted</p> <p>(i) via email to the Company's Share Registrar at gpe@mncsingapore.com; or</p> <p>(ii) via the online process through the pre-registration website at the URL https://www.sats.com.sg/egm,</p> <p>in each case, by <u>2.30 p.m. on 15 January 2023</u>.</p> <p>A shareholder who wishes to submit an instrument appointing a proxy(ies) by post or via email can either use the hard copy of the proxy form which is sent to him/her/it by post or download a copy of the proxy form electronically from the Company's website or the SGX website, and complete and sign the proxy form before submitting it by post to the address provided above, or before submitting it via email (e.g., by enclosing a completed and signed PDF copy of the proxy form) to the email address provided above. A shareholder may also appoint a proxy(ies) via the online process through the pre-registration website at the URL https://www.sats.com.sg/egm.</p> <p>Shareholders are strongly encouraged to submit completed instruments appointing a proxy(ies) electronically via email or appoint a proxy(ies) via the online process through the pre-registration website at the URL https://www.sats.com.sg/egm.</p> <p>CPF and SRS investors should <u>not</u> submit instruments appointing a proxy(ies). CPF and SRS investors who wish to appoint the Chairman of the Meeting as proxy to vote on their behalf at the EGM should approach their respective CPF Agent Banks or SRS Operators to submit their votes by <u>5.00 p.m. on 6 January 2023</u>. Can I appoint two proxies to attend the EGM on my behalf?	<p>A shareholder (who is not a relevant intermediary) is entitled to appoint not more than two proxies to attend, speak and vote at the EGM. Where a shareholder's instrument appointing a proxy(ies) appoints more than one proxy, the proportion of the shareholding concerned to be presented by each proxy shall be specified in the instrument.</p> <p>A shareholder who is a relevant intermediary is entitled to appoint more than two proxies to attend, speak and vote at the EGM, but each proxy must be appointed to exercise the rights attached to a different share or shares held by such shareholder. Where such shareholder's instrument appointing a proxy(ies) appoints more than two proxies, the number and class of shares in relation to which each proxy has been appointed shall be specified in the instrument.</p> <p>The proxy form contains more information on the appointment of proxy(ies) and can be found at the following websites:</p> <ol style="list-style-type: none"> pre-registration website at the URL https://www.sats.com.sg/egm; and SGX website at the URL https://www.sgx.com/securities/company-announcements. <p>A hard copy of the proxy form will also be sent to shareholders.</p>
Can I appoint two proxies in the alternative to attend the EGM on my behalf?	<p>Yes. Where a shareholder appoints two proxies in the alternative, the two proxies will each receive a different proxy code for pre-registration and upon successful authentication, both will be able to attend and participate in the Physical Meeting and/or the Virtual Meeting.</p> <p>In the event that both proxies attend and participate in the Physical Meeting and/or the Virtual Meeting, only the votes cast during the live voting by the proxy who first registered at the registration counter(s) outside the EGM venue on the day of the EGM or who first accessed the live audio-visual webcast, will be counted.</p>
Can I appoint two proxies jointly to attend the EGM on my behalf?	<p>Yes. Where a shareholder appoints two proxies jointly, each in respect of a specified proportion of his/her/its shareholding, different proxy codes will be assigned to both proxies for pre-registration.</p> <p>Upon successful authentication, both proxies will be able to attend and participate in the Physical Meeting and/or the Virtual Meeting, but will only be able to vote in respect of the specified proportion of shareholding in respect of which that proxy has been appointed.</p>
Is there a deadline to submit instruments appointing a proxy(ies)?	<p>Yes, all instruments appointing a proxy(ies) must be submitted by <u>2.30 p.m. on 15 January 2023</u>.</p>



LIVE VOTING/APPOINTMENT OF PROXY(IES)	
Question	Answers
<p>If I have submitted a proxy form but subsequently decide to attend the EGM personally, can I withdraw my proxy form?</p>	<p>Yes. Completion and return of the instrument appointing a proxy(ies) does not preclude a shareholder from attending, speaking and voting at the EGM.</p> <p>You may view, resubmit or withdraw your proxy appointments before 2.30 p.m. on 15 January 2023 via the URL https://www.sats.com.sg/egm; or by post to the Company's Share Registrar, M & C Services Private Limited, at 112 Robinson Road #05-01, Singapore 068902; or via email to the Company's Share Registrar at gpe@mncsingapore.com.</p> <p>After you have appointed a proxy(ies) to attend, speak and vote at the EGM on your behalf, you will be given observer rights where you can observe and/or listen to the EGM proceedings in person at the Physical Meeting or by way of electronic means at the Virtual Meeting. As an observer, you will not be able to vote live at the EGM.</p> <p>Should you decide to attend the Physical Meeting and register at the registration counter(s) outside the EGM venue on the day of the EGM, you will need to decide if you would like to revoke your proxy appointment(s). If yes, you will be automatically given the full rights to participate in the EGM, including the ability to ask questions and vote live at the EGM. Your proxy(ies)' rights to participate at the EGM will then be revoked, and the instrument appointing a proxy(ies) will be treated as null and void.</p> <p>Should you decide to attend the EGM via the live audio-visual webcast and log in on the day of the EGM, i.e., on 18 January 2023 at 2.30 p.m., a prompt window asking if you would like to revoke your proxy appointment(s) will appear. If you select "Yes", you will be automatically given the full rights to participate in the EGM, including the ability to ask questions and vote live at the EGM. Your proxy(ies)' rights to participate at the EGM will then be revoked, and the instrument appointing a proxy(ies) will be treated as null and void.</p>

<p>How would I be able to submit questions in advance of the EGM?</p>	<p>Shareholders (including CPF and SRS investors) can submit substantial and relevant questions related to the resolution to be tabled for approval at the EGM to the Chairman of the Meeting, in advance of the EGM, in the following manner:</p> <ol style="list-style-type: none"> Via pre-registration website. Shareholders (including CPF and SRS investors) who pre-register for the EGM may submit their questions via the pre-registration website at the URL https://www.sats.com.sg/egm. Via email. Shareholders (including CPF and SRS investors) may submit their questions via email to sats_ir@sats.com.sg. By post. <p>Would all the questions submitted in advance of the EGM be addressed?</p>	<p>The Company will address substantial and relevant questions received by the 11 January 2023 deadline from shareholders by publishing our responses to such questions on the Company's website at the URL https://www.sats.com.sg/egm and on the SGX website at the URL https://www.sgx.com/securities/company-announcements before the EGM.</p> <p>We will address any subsequent clarifications sought, or substantial and relevant follow-up questions (which are related to the resolution to be tabled for approval at the EGM) received, after the 11 January 2023 deadline for the submission of questions in advance of the EGM which have not already been addressed prior to the EGM, as well as those substantial and relevant questions received live at the EGM itself, during the EGM.</p> <p>Where substantially similar questions are received, we will consolidate such questions, and consequently, not all questions may be individually addressed.</p>
<p>Is there a deadline for questions to be submitted in advance?</p>	<p>Yes, all questions submitted in advance of the EGM must be received by the Company by <u>5.00 p.m. on 11 January 2023</u>.</p>

<p>How would I be able to ask questions live at the EGM?</p>	<p>Shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), can ask the Chairman of the Meeting substantial and relevant questions related to the resolution to be tabled for approval at the EGM, live at the EGM. Attendees at the Virtual Meeting can do this by submitting text-based questions via the live chat function on the online platform for the EGM. The live chat function will also be available for use by attendees at the Physical Meeting.</p> <p>Shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), will <u>not</u> be able to submit text-based questions live at the EGM <u>via the audio-only stream</u> of the EGM proceedings.</p> <p>Please note that shareholders (including CPF and SRS investors) and, where applicable, appointed proxy(ies), who wish to ask questions live at the EGM should pre-register by 2.30 p.m. on 15 January 2023 at the pre-registration website at the URL https://www.sats.com.sg/egm.</p>
<p>Would all the questions asked live at the EGM be addressed?</p>	<p>During the EGM, we will endeavour to address as many substantial and relevant questions (which are related to the resolution to be tabled for approval at the EGM) which have not already been addressed prior to the EGM, as well as those substantial and relevant questions received live at the EGM itself, as we can.</p> <p>Where substantially similar questions are received, we will consolidate such questions, and consequently, not all questions may be individually addressed.</p>
<p>Would the attendees at the EGM be able to see the live questions raised by other shareholders and proxies via the live chat function during the EGM?</p>	<p>No, shareholders and, where applicable, appointed proxy(ies), will not be able to see the questions raised by other shareholders and appointed proxies via the live chat function during the EGM.</p>
<p>Would I or my proxy(ies) be able to ask questions live at the EGM if I am or my proxy(ies) is/are listening to the audio-only stream of the EGM proceedings?</p>	<p>No, you and, where applicable, your appointed proxy(ies) will <u>not</u> be able to submit text-based questions live at the EGM via the audio-only stream of the EGM proceedings.</p> <p>If you are attending and participating in the Virtual Meeting, the live Q&A function is only available on the audio-visual webcast of the EGM proceedings.</p>

<p>How do I or my proxy(ies) submit my vote live at the EGM?</p>	<p>The resolution to be tabled for approval at the EGM will be proposed and thereafter put to the vote by poll. Voting at both the Physical Meeting and the Virtual Meeting will be conducted via an online platform.</p> <p><u>Voting instructions for shareholders:</u></p> <p>Once voting commences, the resolution and the voting options will appear automatically on the screen of your desktop, laptop, tablet or mobile devices. You can proceed to cast your vote for the resolution. You should click “For” if you wish to vote for the resolution, click “Against” if you wish to vote against the resolution, or click “Abstain” if you wish to abstain from voting on the resolution.</p> <p>If you wish to change your vote, you can select a new choice for the resolution. If you wish to withdraw your vote, you should click “Cancel” for the resolution.</p> <p>If you do not select “For”, “Against”, or “Abstain” in relation to the resolution before voting closes, your vote will <u>not</u> be recorded in respect of the resolution.</p> <p><u>Voting instructions for proxy(ies):</u></p> <p>Where the shareholder has already indicated his/her/its specific voting instructions on the instrument appointing a proxy(ies), the voting option for the proxy(ies) to vote on the resolution tabled at the EGM cannot be edited. The voting will be based on the specified voting instructions indicated by the shareholder. Appointed proxy(ies) should click on the “Submit Vote” button. If the proxy(ies) does not submit the vote, the vote will <u>not</u> be recorded.</p> <p>Where the shareholder has not provided specific voting instructions on the instrument appointing a proxy(ies), the appointed proxy(ies) can vote live at the EGM according to his/her/their discretion. <p>Would I or my proxy(ies) be able to vote live at the EGM if I am, or my proxy(ies) is/are listening to the audio-only stream of the EGM proceedings?</p>	<p>No, you and, where applicable, your appointed proxy(ies) will <u>not</u> be able to vote live at the EGM via the audio-only stream of the EGM proceedings. If you are attending and participating in the Virtual Meeting, the live voting function is only available on the live audio-visual webcast of the EGM proceedings.</p>
