### **ANNUAL GENERAL MEETING TO BE HELD ON 24 SEPTEMBER 2020**

- 1. **Background**. SATS Ltd. (the "Company" or "SATS") refers to:
  - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
  - (c) the joint statement by the Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020 and 22 June 2020) which provides additional guidance on the conduct of general meetings during the period from 27 March 2020 to 30 September 2020; and
  - (d) its announcement of 29 May 2020 stating, *inter alia*, that it would make use of the automatic time extension of 60 days provided by Singapore Exchange Regulation to issuers with financial year-ends on or before 31 March 2020 to hold their annual general meetings.
- Date, time and conduct of Annual General Meeting. SATS is pleased to announce that pursuant to the Order, its Annual General Meeting ("AGM") will be convened and held by way of electronic means on <u>Thursday</u>, <u>24 September 2020 at 11.00 a.m.</u> (Singapore time). Our Chairman, Ms Euleen Goh, will conduct the proceedings of the AGM.
- 3. **Notice of AGM and proxy form.** The Notice of AGM and proxy form will be sent to shareholders solely by electronic means via publication on the Company's website and will also be made available on the SGX website<sup>1</sup>. **Printed copies of these documents will not be sent to shareholders.**

- 4. **No personal attendance at AGM**. Due to the current COVID-19 situation in Singapore, shareholders will not be able to attend the AGM in person.
- 5. **Alternative arrangements for participation in the AGM**. Shareholders may participate in the AGM by:
  - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (b) submitting questions in advance of the AGM; and/or
  - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM by shareholders, including CPF and SRS investors, are set out in the Appendix to this announcement. In addition, CPF and SRS investors who wish to appoint the Chairman of the Meeting as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by **5.00 p.m. on 14 September 2020**.

6. **Pre-registration.** Shareholders, including CPF and SRS investors, can pre-register at the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2020">https://www.sats.com.sg/AGM2020</a> from 11.00 a.m. on 26 August 2020 up to 11.00 a.m. on 21 September 2020 to enable SATS to verify their status as shareholders.

- 7. **Persons who hold shares through relevant intermediaries**. Persons who hold SATS shares through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), other than CPF and SRS investors, and who wish to participate in the AGM by:
  - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (b) submitting questions in advance of the AGM; and/or
  - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,



should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.

# Steps for pre-registration, pre-submission of questions and voting at the AGM

Shareholders will be able to observe and/or listen to the AGM proceedings through a live audio-visual webcast or live audio-only stream via their mobile phones, tablets or computers, submit questions in advance of the AGM and vote by appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

To do so, they will need to complete the following steps:

	<b>Minutes of AGM</b> . The Company will publish the minutes of the AGM on the Company's website and on SGXNet.
Submit instruments appointing a proxy to vote	Appointment of Chairman of the Meeting as proxy. Shareholders (whether individual or corporate) who pre-register to observe and/or listen to the AGM proceedings and wish to vote on the resolutions to be tabled at the AGM must appoint the Chairman of the Meeting as their proxy to attend, speak and vote on their behalf at the AGM, in accordance with the instructions on the instrument appointing a proxy.

**Specific voting instructions to be given**. Where shareholders (whether individual or corporate) appoint the Chairman of the Meeting as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the instrument appointing a proxy, failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid.

**Manner of appointment**. Shareholders can submit an instrument appointing the Chairman of the Meeting as proxy in the following manner:

- (a) **By post or via email**. Shareholders may submit proxy forms by post or via email.
- (b) Via pre-registration website. Shareholders who pre-register to observe and/or listen to the AGM proceedings (other than CPF and SRS investors) may also appoint the Chairman of the Meeting as proxy via the pre-registration website at the URL <a href="https://www.sats.com.sg/AGM2020">https://www.sats.com.sg/AGM2020</a>.

CPF and SRS investors who wish to appoint the Chairman of the Meeting as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by **5.00 p.m. on 14 September 2020.** 

**Method of submission**. Instruments appointing a proxy must be submitted in the following manner:

- (b) if submitted electronically:
