SUPPLY OF TOUCHLESS (SENSOR TYPE) FLUSH VALVES AND TAPS FOR CHANGI SATS AFT (Air freight Terminals) TOILETS

1. SCOPE OF WORKS

- 1.1 SATS Limited is requesting for the supply and delivery of (Touchless) Concealed Urinal Sensor Flush Valve, Concealed Toilet Sensor Flush Valve and Sensor Water Tap.
- 1.2 The Contractor shall deliver the products to 30 Airline Rd, Singapore 819830 unless otherwise stated.
- 1.3 The Contractor shall supply and deliver 50 quantity of Concealed Urinal Sensor Flush Valve with 3-tick WELS Rating.
- 1.4 The Contractor shall supply and deliver 100 quantity of Concealed Automatic Toilet Flush Valve include vacuum breaker with 3-tick WELS Rating.
- 1.5 The Contractor shall supply and deliver 100 quantity of fully automated sensor activation polished brass with chrome finish deck mounted sensor taps with 3-tick WELS Rating and self-adjusting signal frequency to prevent interference with other sensor products.
- 1.6 The Contractor shall submit all product samples and catalogues to SATS Limited together with their Bid Price.
- 1.7 The Contractor shall provide warranty and for all parts or component supplied for a period of eighteen (18) months or as per manufacturer's warranty approved by SATS Limited from the date of delivery.

2. PROPOSAL FEE

- 2.1 The Contractor shall include all labor, materials and transport in their Bid Price. Unless otherwise stated in this Specification, all cost shall be deemed to be included in the Bid Price.
- 2.2 In the event of any variation for any addition or omission, the Contractor payment shall be added or deducted according to the unit rate in the Quotation Priced Breakdown.
- 2.3 SATS Limited reserve the rights to award the project in parts or phases at SATS sole discretion. (Example, award Sensor Tap only or award half the quantity stipulated)

2.4 The Bid Price submitted shall be valid for at least 12 months. SATS Limited reserved the right to make additional purchase according to the submitted price per unit within the 12 months at any quantity. The Contractor shall be entitled to charge for delivery, where the total quantity in a single Purchase Order falls below 10 numbers.

3. PROJECT SCHEDULE

3.1 The deliverables shall be supply and delivered to the approved site by SATS Limited within 3 weeks from confirmation.

3.2 The Contractor shall be required to submit all document to prove the completion of work. The document shall include but not limited to; delivery orders and warranty certificate.

3.3 Under the contract, the payment will be honoured within 60 days of the receipt of invoice and certification by the Company’s executive in charge for its release.
