(ii) Restricted Share Plan ("RSP") and Performance Share Plan ("PSP")

Management employees are entitled to two share-based incentive plans, the RSP and PSP, which were approved by the shareholders of the Company on 19 July 2005. Both share plans which expired on July 2015 were subsequently approved during the 41st Annual General Meeting held on 23 July 2014 for further extension of 10 years to July 2025.

The number of restricted shares awarded is based on individual and corporate performance and the final number of restricted shares could range between 0% and 120% of the initial grant of the restricted shares. PSP has a performance period of three years. The number of performance shares awarded is based on individual and corporate performance and the final performance shares awarded could range between 0% and 150% of the initial grant, subject to achievement of the pre-determined targets.

GROUP FINANCIAL PERFORMANCE

First Quarter FY2017-18

The Group closed the first quarter of FY2017-18 with a net profit attributable to owners of the Company of \$57.3 million, \$6.8 million or 10.6% lower than the last corresponding quarter. This is mainly due to the absence of last year's gain from the disposal of assets held for sale, the Senoko plant. Notwithstanding, the underlying net profit was \$1.8 million or 3.2% above last year.

Group's revenue was \$426.5 million, an increase of \$2.3 million or 0.5%. The revenue from Food Solutions fell \$7 million or 2.9% to \$233.1 million while Gateway Services' revenue grew \$9.3 million or 5.1% to \$193.1 million.

The Group's expenditure in the quarter was \$373 million, an increase of \$3.3 million or 0.9% compared to the first quarter in FY2016-17. With various automation, productivity and cost management initiatives, staff costs and premise and utilities expenses were maintained near to last year level. Cost of raw materials was lower by \$4.5 million due to lower Food Solutions' revenue. Conversely, licence fees increased significantly by \$4.3 million due mainly to cessation of rebates while depreciation and amortisation charges increased \$1 million in line with additional capital expenditure incurred. Other costs increased \$2 million mainly due to higher costs incurred on equipment maintenance, fuel consumption and marketing activities.

Operating profit for the quarter was \$53.5 million, a decline of \$1 million or 1.8% compared to the same quarter last year.

Share of after-tax profits from associates/joint ventures for the quarter was \$15.5 million, an improvement of \$3.3 million or 27% over the same period last year, with higher contributions from both Gateway and Food Solutions' associates/joint ventures.

GROUP FINANCIAL POSITION REVIEW

Total equity of the Group stood at \$1,743.9 million as at 30 June 2017, an increase of \$52.7 million compared to \$1,691.2 million as at 31 March 2017. The increase in equity resulted mainly from profits generated during the quarter, partly negated by the foreign currency translation losses suffered.

The non-current assets were lower by \$9.5 million mainly due to the transfer of the carrying value of the investment in an associate Jilin Zhong Xin Cheng Food Co., Ltd ("Jilin JVCo") amounting to \$7.8 million to assets held for sale. During the quarter, an agreement was signed to transfer the whole equity stake in Jilin JVCo to our 100% owned subsidiary SG IPF Pte. Ltd. ("SGIPF"). Concurrently an agreement was signed with Jilin IPF Pte. Ltd. ("JIPF"), a wholly owned subsidiary of Singbridge Corporate Pte. Ltd., to inject capital into SGIPF for 40% stake in SGIPF. Upon completion of these transactions, SGIPF will be classified as a joint venture of the Group. As a result of these transactions, the assets and liabilities for SGIPF and the investment in Jilin JVCo have been classified as disposal groups held for sale as at 30 June 2017. Announcement of these agreements were made on 7 June 2017.

Current assets increased \$71.5 million over the balances as at 31 March 2017, particularly in trade and other receivables and cash and short-term deposits. Cash and short-term deposits increased \$38.8 million mainly attributed to cash generated from operations. Trade and other receivables and prepayment increases were attributed to revenue increase and operational needs.

Apart from the above mentioned Jilin JVCo and SGIPF transactions, assets and liabilities held for sale also included the impending sale of 51% stake in SATS HK Limited ("SHK"), 4% stake in Asia Airfreight Terminal Company Limited and an investment property which were reported as at 31 March 2017.

Total liabilities of the Group increased \$9.3 million to \$597.5 million as at 30 June 2017. The increases in liabilities were due to higher trade and other payables as well as income tax provision.

GROUP CASH FLOWS REVIEW

The 1Q FY2017-18 net cash from operating activities was \$38.7 million lower than last corresponding quarter mainly due to the movement in working capital.

Net cash used in investing activities was lower compared to the same period last financial year mainly attributed to absence of long-term investment as well as lower investments in associates/joint ventures, dividends from associates/joint ventures and proceeds from disposal of assets held for sale. The proceeds from disposal of assets held for sale for the current quarter refers to partial payment received for the sale of the investment property.

OUTLOOK

There is no indication that low yields across the airline industry will improve in the near future, so pricing pressure on SATS is expected to continue.

However, the growth in air travel, eCommerce and demand for high quality, safe food remain strong. Therefore, we intend to make further investments in capital and new business opportunities in additional locations in the coming year to prepare for the future.

We will also continue to increase the use of technology to improve productivity, gain greater scale economies and link our regional operations to serve our customers better.
