Circumstances giving rise to deemed interests (*if the interest is such*): [You may attach a chart in item 11 to illustrate how the Substantial Shareholder/Unitholder's deemed interest arises] On 22 December 2020, Temasek Holdings (Private) Limited ("Temasek"), the holding company of Tembusu, completed an internal restructuring (the "Internal Restructure") in which the interest of certain fund management entities including 51 per cent of the shares of FFMC Holdings Pte Ltd ("FFMH"), previously held by a wholly owned subsidiary of Temasek, were transferred to Seviora Holdings Pte. Ltd. ("Seviora"), an indirect wholly-owned subsidiary of each of Tembusu and Temasek. Tembusu was able to report the change of interest in the voting shares of the Listed Issuer ("Shares") only when it was able to collate the aggregate interests of FFMH in the Shares with that of the existing deemed interest of Tembusu in the Shares. Each of FFMH and Seviora is an independently managed Temasek portfolio company. Tembusu is not involved in their business or operating decisions, including those regarding their position in the Shares. For the avoidance of doubt, the Internal Restructure has not resulted in any change to the interest of Temasek in the Shares.

Tembusu is filing this notification form to report a change in the percentage level of its deemed interest in Shares from 39.99% to 40.01% due to the acquisition of 233,500 Shares on 11 January 2021 by Fullerton as investment manager.

Tembusu's deemed interest arises from the aggregation of the interests of Venezio Investments Pte. Ltd. ("Venezio"), Fullerton and Singapore Airlines Limited ("SIA") as follows.
